Election to the Academic Council of KUFOS (Under Sections 17.1.x, xi, xii of KUFOS Act 5 of 2011)

NOTIFICATION

As per order No. GA2/249/14 dt. 25.05.2017 new Head of the Departments were appointed since the tenure of appointment of HoD's expired on completion of 3 years. As per Sections 17.1.x of KUFOS Act 2010, five HoD's have to be elected to the Academic Council of KUFOS from among themselves. As the faculty member elected to the Academic Council from the School of Fisheries Resource Management & Harvest Technology, has appointed as HoD in KUFOS, election has to be conducted in the School of Fisheries Resource Management & Harvest Technology for electing a faculty member from among the faculty member of the School vide Sections 17.1.xii of KUFOS Act 2010.

As the PG students elected to Academic Council were passed out election have to be conducted among the PG students of KUFOS as per Sections 17.1.xii of KUFOS Act 5 of 2011.

It is hereby notified that, the Vice Chancellor in exercise of the powers conferred on him as per Section 2(6) of Chapter XXI of the KUFOS (Conduct of Election to various Authorities or Bodies) First Statute 2013 in accordance with the procedure prescribed by the Statute to conduct election to the Academic Council for electing the following members,

1. Five Heads of Departments of the University elected from among themselves
2. One faculty member of the School of Fisheries Resource Management & Harvest Technology from among themselves
3. Two members elected from among the Postgraduate students of the University

As per section 6 of Chapter XXI of the KUFOS First Statute 2013, electoral rolls shall be published in the University Office not less than thirty clear days before the date of notification of the election. Hence it is hereby notified that the following Electoral rolls are published in the University Office on the date noted against each.

1. Electoral Roll of HoD's
2. School wise list of teachers of the University other than Dean, Directors of Schools, Heads of Departments–For electing one faculty member of School of FRM &HT.
3. PG students of the University - For electing two PG students among themselves

The names of persons who are on the electoral body 30 days before the date of publication of the roll alone shall be included in the electoral roll and such persons alone shall be entitled to participate in the election.

Provided that any person who ceases to be a member of an electoral body before the date of issue of the ballot paper from the University office shall not be entitled to participate in the election.

It shall be competent for the Vice Chancellor to make any addition, correction, alteration or deletion in any electoral roll, provided that the fact necessitating such correction or alteration or deletion is brought to his notice within fifteen days of the publication of the electoral roll and he is satisfied that such correction or alteration or deletion is necessary.

The copies of the electoral roll or part thereof shall be made available to the electors or to the general public or another body on request and payment of Rupees Fifty towards the price for each or part thereof, by the Vice Chancellor.
