**Note:**

Absents of candidates in reservation categories, the seats will be converted to SM/General Category.

Candidates shall produce the following documents at the time of admission:

- a. Original SSLC/CBSE/ICSE and Plus 2/VHSE certificates
- b. Transfer and Conduct certificates from the institution last attended.
- c. Physically challenged candidates shall produce original medical certificate from a Medical Officer not below the rank of a Civil Surgeon.
- d. The candidates belonging to **SC/ST and OEC** categories shall produce original **Community/Caste Certificate**.
- e. **Socially and Economically Backward Community (SEBC)** category of candidates claiming reservation shall produce original **Non –creamy Layer Certificate** in the prescribed format.
- f. Candidates belonging to '**Children of Fishermen**' category shall produce original and copy of the registration card issued by the Kerala State Fishermen Welfare Fund Board or certificate from the Fisheries Department.
- g. The candidates shall open a savings bank account in their name in any of the nationalized banks, preferably State Bank of India, and produce a copy of the first page of the bank account passbook
- h. Copy of Aadhar Card
- i. 3 Passport size photographs
- j. Admit card & Candidates data sheet from the Commissioner for Entrance Examination
