**SPECIFICATIONS**

**Technical Specifications:**

- Should determine the water absorption/penetration (Cobb value) which is the quantity of water absorbed by surface of 100 cm<sup>2</sup> of the specimen on one side only in a specified time under a specified head of water.
- Provided with tilting arrangement to remove water automatically
- Height marks should be provided at 10 mm, 25 mm and 100 mm for maintaining correct water head.
- Roller weight of 10 kg is to be supplied.
- Should be suitable for testing as per ASTM D3285-93, TAPPI T 441 om-98m FEFCO TM 7,1997 and IS standard 1060(Part I-1996)

**Other requirements**

- Warranty for a period of 1 year
- Vendor should mention the pre-installation requirements
- Copy of the system manual should be provided in soft copy form and one hard copy
- Standard Operating Procedure (SOP) of the equipment should be provided in detail
- Vendor should provide Do's & Don't for the Instrument
