As per reference 1st read above, orders were issued by the Government of Kerala revising the rate of Dearness Allowance/Dearness Relief payable in respect of State Government Employees, Teachers and pensioners as below.

The enhancement of DA/DR to the staff of the University w.e.f 01.01.2019 in accordance with the G.O. read above was placed as Agenda No.1450 in the 72nd Governing Council meeting held on 15.02.2021 for approval and the Governing Council resolved to adopt the G.O.(P) No.25/2021/Fin dt 08.02.2021 and to approve the revised rate of DA/DR for implementation w.e.f. 01.01.2019.

The Dearness Allowance at the enhanced rate will be paid in cash with the salary for the month of March 2021 onwards and arrears upto February 2021 will be merged in the PF account. The revised Dearness Relief will be paid as per the Government Order referred above.

In the circumstances, in consonance with the decision of the GC in KUFOS, vide reference read 2nd above meeting, sanction is hereby accorded to enhance the DA/DR to the Teachers/ employees/ labourers /pensioners of the University w.e.f. 01.01.2019 in accordance with the G.O.(P) No.25/2021/Fin dt 08.02.2021.
