Name of the Post	Empanelled Guest Faculty (They have to attend duties related to academic and examination. During exigencies, or on direction of the Dean of the concerned faculties or of the University,they shall attend full day duty.)
No. of Vacancy	Deployment of empanelled guest faculty shall be limited to requirement.
Remuneration	Guest faculty who have the prescribed qualifications with NET/PhD - Rs 1500/- per hour for theory and Rs 750/- per hour for practical. (Subject to a maximum of Rs 3000/- per day and Rs 50,000/- per month.) Guest faculty who have the prescribed qualifications but without NET/PhD - Rs. 1000/- per hour for theory and Rs. 500/- per hour for practical (Subject to a maximum of Rs. 2000/- per day and Rs. 32,000/- per month). No additional honorarium shall be claimed for attending the additional duties entrusted by the Dean of Faculty or by the University.

General Condition

1. Those who are interested may report at 10 am at KUFOS Head Quarters, Panangad and submit application in prescribed format attached below along with the copies of certificates to prove essential educational qualification, age, caste and experience etc.
2. Eligible candidates may attend the interview at 2.00 pm with biodata, original certificates and one set of photocopies of the certificates to prove qualification, age and experience etc.
3. The clearing of NET/SLET/SET shall not be required for candidates in such disciplines for which NET/SLET/SET has not been conducted. In shortage of candidates with NET , candidates those who have no NET shall be considered as per the norms stipulated according to the decision of the university authorities.
4. Guidelines issued by UGC from time to time shall be applicable.
5. A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC) (Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility

and assessing good academic record for direct recruitment. The eligibility marks of 55% (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.

6. A relaxation of 5% shall be provided (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
7. The University reserves the right to restrict the number of candidates to attend the interview on the basis of qualifications/suitability of candidate to the post with experience prescribed in the notification.
8. The admissible qualification shall be those acquired as on the date of interview.
9. No interim queries regarding test/interview/selection will be entertained.
10. Canvassing in any form will be a disqualification.
11. Application Fee: Rs.500/- (Rupees Five Hundred only - For Candidates other than SC/ST) and Rs.125/- (Rupees One Hundred and Twenty Five only - For SC/ST Candidates)
