#### **Essential Qualifications**

- i. Master of Fisheries Science (MFSc) in Aquatic Environment Management/Fishery Hydrography
- ii. ICAR/UGC/CSIR NET mandatory
- iii. Essential: Bachelor degree in Fisheries Science approved by ICAR
- iv. PhD in the relevant subject.

Teaching experience/research publications in Scopus Indexed Journals, UGC CARE Lists/Patents are desirable.

## Other eligibility conditions as per UGC Regulations 2018:-

- 1. The clearing of ICAR/UGC/CSIR NET is mandatory
- The clearing of NET / SLET / SET will not be required for candidates possessing a PhD Degree as per UGC Regulations / ICAR Guidelines
- 3. At least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed) in the subjects specified for the posts in the Faculty of Fisheries Science.
- 4. Other criteria as per UGC Regulations 2018 would also be applicable.
- 5. The Academic score as specified in Appendix II (Table 3A) of UGC Regulations 2018 for

- Universities shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.
- NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.

#### General instructions

- 1. A relaxation of 5% marks shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acidattack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- A relaxation of 5% marks for the Master's Degree shall be provided (from 55% to 50% of the marks), to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
- 3. The time taken by candidates to acquire MPhil and/or PhD Degree shall not be considered as teaching/research experience to be claimed for appointment to the teaching positions. Further the period of active service spent on pursuing research degree simultaneously with teaching assignments, without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment.
- 4. Age limit for applying to the posts shall be as per University Grants Commission/ Indian Council for Agriculture Research and norms existing or issued from time to time.
- 5. The prescribed essential qualifications are the minimum and mere possession of the same does not entitle candidates to be called for interview. Where the number of applications received is large and/or where it will not be convenient or possible to interview all the candidates, the University at its discretion may restrict the number of candidates to a reasonable limit on the basis of qualifications/experience prescribed in the advertisement.
- 6. The qualification prescribed shall be as on the last date for receipt of application.
- 7. Candidates who apply for reserved posts should clearly state the reservation category they

- belong to. They must also enclose attested photocopy of Caste Certificate/EWS certrificate issued by the competent authority.
- 8. The candidates applying to the post reserved for Economically Weaker Sections (EWS) shall produce the Income and Asset Certificates from competent authorities which are appended as Annexures II & IV of G.O. (Ms.) No. 23/2022/P&ARD dated 04.10.2022, whichever is applicable, for the benefit of reservation. The candidates shall also fulfill the criteria stipulated in the G.O. (P) No. 1/2020/P & ARD dated 03.01.2020 and G.O. (Ms.) No. 2/2020/P&ARD dated 12.02.2020 for considering reservation under EWS category.
- 9. If any vacancy earmarked for Economically Weaker Sections cannot be filled up due to non-availability of suitable candidates belonging to Economically Weaker Sections, such vacancies shall not be carried forward as backlog and such vacancy shall be allotted to open competition in the next phase of recruitment.
- 10. No interim queries regarding interview/selection will be entertained.
- 11. Canvassing in any form will be a disqualification.
- 12. Interested candidates should apply in duplicate (2 copies) in the <u>prescribed format attached</u> <u>here under along with photocopies of all supporting documents.</u> Both the copies shall be properly bound (in book form).
