LIMITED TENDER NOTICE

Sealed competitive tenders are invited from the local book suppliers/ publishers for the supply of books, as per the list appended, to the KUFOS Library. The discount rate that can be allowed to each publisher category under Foreign/ Indian publishers should be quoted in the prescribed format provided with this notice.

Terms and Conditions

- 1. Tender should be submitted in the prescribed format. The list of available titles is also to be given along with the quotation.
- 2. The bidders who quote discount rates for books of Foreign Publishers are liable to supply Indian editions of those publishers if they are available.
- 3. Demand Draft for Rs. 2000/- drawn on State Bank of Travancore in favour of the Finance Officer, KUFOS, Panangad, Kochi should be furnished along with the quotation.
- 4. The bidders who quote discount rates for "Foreign Publishers" category should enclose original Authentications from the Publishers to prove them as authorized distributor/ supplier of books of those publishers.
- 5. Tenders not in the prescribed format and without documents as required above will be rejected.
- 6. The tenderer has to supply books within two weeks of the supply order.
- 7. The purchase may be limited at any stage according to the availability of funds and prioritization of books.
- 8. Supply should be made in single lot as far as possible and bill must be furnished with duplicate copies, stamped pre-receipt should be enclosed along with the bills which exceeds the total amount of Rs. 5000/-.
- 9. Only the latest paper back editions of the books should be supplied and they should not be remainder titles. Books available only on e-commerce sites and print on demand are also liable to be supplied.
- 10. The prices should be correctly charged in accordance with the Publisher's/ Importer's/ Distributor's invoices and publisher catalogues and a copy of the same should be produced as price proof in case of foreign books and Indian books which have no printed price.
- 11. If any change in price, title author edition, volume or publisher is noted against an item in the supply order, it should be brought to the notice of the library and confirmation is to be obtained before delivery.
- 12. If any of the foreign books have Indian price they should be supplied at the Indian price.
- 13. The price should be indicated in the original currencies. The conversion rate is to be made as per GOC rates prevailing on the bill date.
- 14.Discount should be given at the rate quoted by the vendor/approved by our office for each publisher category. Name of publisher should be indicated in the bill/invoice against each title.
- 15.If any approved vendor fails to fulfill any of the above terms and conditions they will be blacklisted and removed from the University Book Suppliers List and the Security Deposit if any Panangad P.O. 682 506, kochi, Kerala, India.
