**NOTICE FOR RUNNING CONTRACT 2025-26**

Running contract proposals for the year **2025-26** for the supply of **Chemicals/Glasswares/Plasticwares** for use in the various Academic/Research programs in the University are invited from **manufacturing firms in India**, and from **principal dealers/distributors in India** in case of foreign items.

The firms may submit their proposals with discount rates for the year 2025-26 on the current price-list, copies of which may be submitted in soft or hard form. The period of contract shall be one year from the date of execution of agreement or till a new running contract is entered into, whichever is later. The dealers may also submit proposals on behalf of manufacturers with their authorization letter.

The accepted proposals will be published in the KUFOS website in due course.

The firms whose proposals are accepted will have to execute a Running Contract Agreement in favour of the Registrar, KUFOS. They shall furnish a Security Deposit of Rs. 1000/- (Rupees One Thousand only) with each agreement. The Security Deposit may be paid by means of e-payment to the following account:

Documents in proof of the transaction shall be attached along with the tender.

The proposal should be submitted to the **Registrar** on or before **07/05/2025 at 3.00 PM**. The envelope containing the proposals should bear the superscription "**RC for Chemicals/Glasswares/Plasticwares ,GA9/3425/2023** " Proposals received after the due date and time will not be considered under any circumstances.

If it is found that the security deposit of Rs. 1000/- is lower than the stipulated amount at any point during the tenure of the contract, the University reserves the right to collect the difference in amount from the firms who have entered into agreement with the University.

*It is hereby informed that all firms currently holding valid and running contracts with the University for the supply of **Chemicals, Glasswares, and Plasticwares** shall continue the supply of these items without interruption **until the commencement of the new contract.***
