1. **Discussion on Ph.D. Programmes:** It was noted that during the 11th Faculty Board of Studies meeting, a decision was made to recommend the offering of **PhD in Fisheries Extension** and **PhD in Fishing Technology & Engineering**, with guides to be engaged from approved Central Institutes/Centers, due to the unavailability of competent guides at KUFOS. However, it was observed that this recommendation has not yet been presented to the Academic Council for approval.

In the above circumstances, the Faculty Board of Studies recommended the inclusion of the **Ph.D. in Fisheries Extension** and **Ph.D. in Fishing Technology & Engineering** in the **KUFOS Prospectus 2025-26**, subject to the approval of the Hon'ble Vice Chancellor and ratification by the Academic Council.

2. Other Changes:

No other changes were proposed by the Faculty Board of Studies for the KUFOS Prospectus 2025-26.

Dr. K. Dinesh, Dean i/c., expressed his gratitude to all members for their active participation and valuable contributions during the meeting. The meeting was concluded at 12:10 PM.
