### **NOTIFICATION**

Sub: - KUFOS - GC/Senate Section - Election of Teacher Representatives for constituting the 4<sup>th</sup> University Governing Council –Re-Schedule of election and publication of result – Notifying - Reg.

2. Note No. VC 43/2025 dated 08.07.2025 from the Honble Chancellor to the Registrar & Returning Officer

As per Section 12.2 (i) of the Kerala University of Fisheries and Ocean Studies (Amendment) Act, 2021 (Act 18 of 2021), the University Governing Council shall consist of three persons elected by single vote from among the Heads of Departments and Teachers of the University Faculty, of whom one shall be a woman member elected by voting from the regular teachers in the University provided that the elected members of teachers shall not be eligible to be elected continuously.

The names of persons who are on the electoral body 30 days before the date of publication of the roll alone shall be entitled to participate in the election provided that any person who ceases to be a member of an electoral body before the date of issue of the ballot paper from the University office shall not be entitled to participate in the election.

Every elector is at liberty to nominate one duly qualified person to fill up each seat. Nominations shall be made in the prescribed form, copy of which shall be made available from the office of the Registrar & Returning Officer, to the electors whose names are on the electoral rolls.

As per the notification of even no. dated 24.06.2025 the Last date and hour for receipt of nomination for election to University Governing Council from among faculty members was 09.07.2025.

However, due to the Nationwide general strike scheduled on 09.07.2025, vide reference 2<sup>nd</sup> read above the Last date and hour for receipt of nomination for election to University Governing Council from among faculty members stands postponed to 10.07.2025. Accordingly the revised Schedule for election is as follows:

Any candidate may withdraw his/her candidature by notice in writing and delivered in person to the Returning Officer on or before 16.07.2025, 03.30 P.M. Withdrawal once made will be final. The candidates or their agents, if any, appointed in writing and approved by the Returning Officer alone shall be permitted to be present on the occasion of scrutiny of nominations, polling and counting of votes.
