### Technical Specification for Headspace Gas Analyzer

- 1. The equipment should be portable and light weight.
- 2. The equipment should be capable of measuring both the levels of O and CO in the storage environment.
- 3. The resolution of the equipment should be within 0.1% of  $\begin{array}{ccc} O & \text{and} & CO \\ 2 & \end{array}$  levels.
- 4. There should be no or minimum heating time.
- 5. The sampling time should be less than 30 s.
- 7. The vendor should have regional office or supplier in India with in-house repairing &calibration facility and quick supports by experienced and trained engineers for providing maintenance, calibration and application support services.
- 8. Warranty: Minimum 1 year
