**ORDER**

As per Clause (e), Section 18 of Chapter VII of the KUFOS Statute 2013, it shall be the duty of the Registrar to make arrangements for the conduct of elections to the various authorities or bodies of the University under the directions of the Vice-Chancellor.

As per Section 3(a), Chapter XXI Elections Part I, the Registrar shall be the Returning Officer for all elections held by the University. There shall be Assistant Returning Officers, appointed by the Vice Chancellor to assist the Returning Officer in the conduct of the election.

As per read (1) Notification for the Election to the 4<sup>th</sup> Academic Council of KUFOS was published with the schedule of election. As per read (2) Sri. Mohammed Iqbal K. M, Joint Registrar appointed as the Assistant Returning Officer for the conduct of election to be scheduled on **13.01.2026** from **10.00 AM to 03.00 PM**.
