6. The caterer must have a **contingency plan** in place for managing unexpected shortages or delays.
7. The university reserves the right to **reject quotations** that do not meet the specified requirements.
8. Payment terms will be finalized upon selection, with provisions for advance payment and final settlement.
9. **Drinking water provisions** must be arranged by the caterer.


